The Hon'ble High Court vide its order dated 16.09.2019 disposed of the case and passed order. Opertavie part of the order is as under:-

"As per Annexure R-I, State has already extended the benefits, it appears that they had not comprehended the directions of this Court in correct perspective and applied the decision in piecemeal. The State cannot adopt pick and chose policy as affect of enuring benefit to all.

Resultantly, writ petitions are disposed of with a direction to the respondents to give benefits to the petitioners in terms of Annexure R-I and also other affected candidates who have not come to this Court as expeditiously as possible."

In compliance of the said order dated 16.09.2019 and in view of the order 26.03.2019 passed in CWP No. 10534/2017-Kiran Bala & others Vs. State of Hayana & others. You are directed to fix the seniority from the back date as per their merit and give the notional benefit from the date on which their juniors have been appointed on regular basis against Advt. No. 02/2012 on the post of PRT.

So you are hereby directed that as explained above, notional benefit and seniority may be awarded to all the eligible candidates who have not come to the Court for the same relief as mentioned above.
